### CHAIRMAN'S LETTER

#### Dear Valued Wool Producer

I am delighted to have been elected as your new Chairman at an exciting time of change for British Wool.

We are continuously looking to improve as a business against our two key performance benchmarks: the price we return to producers and the service we provide them.

Despite dire predictions at the end of last season from our competitors that the global crossbred wool price would fall significantly, perhaps even halve, our auction prices have been pretty stable this year. You will see from the table on page 3 that the prices we will shortly pay you for this season's wool are higher than the prices offered last year by the competition. It is worth noting, by our Welsh members, that we took all the Welsh mountain wool brought into us, whereas our competition frequently turned this wool away and, as a result, we have finished with a significantly higher weight of Welsh mountain wool this year. In terms of our relative pricing against the other major crossbred wool, i.e. New Zealand, for the last year or so the prices achieved by British Wool have been in line, or at a premium, to New Zealand wool prices (see chart on page3).

Last year we opened a new collection centre in Ropley, Hampshire and this has proved a huge success with many of you choosing to drop your wool there. We are opening new trial Intermediate Centres in Tyrone, Northern Ireland and Penrith, Cumbria (see details on pages 9-12). If you drop your wool at Intermediate Centres there is no onward transport cost incurred by you. We are also relocating our Ashford depot to a new site just 5 minutes from Junction 10 of the M20, the Ashford South exit.

Finally, we are launching an early years' cash flow support scheme for industry new entrants. To qualify, producers must not have been registered with us before and must have kept sheep for fewer than five years. Eligible producers will be paid 100% of their clip value in their first two years and will then transition onto our standard payment scheme over the following three years. New entrants will be paid the same prices per kg as existing members and, over the 5 year life of their scheme, receive the same cash amount as they would have done in the standard payment scheme. We are keen to support the next generation of sheep farmers to ensure the long term health of the sheep industry and your organisation, British Wool.

### ORGANIC WOOL

With improving demand from the bedding & soft furnishings sectors we have seen an increased level of enquiries for Organic Wool. With this in mind we will be paying a premium of **50p/kg** on the fine (203 -291) and medium (305-399) category wools and the following finer micron hill wool grades (614, 615, 653, 654, 655, 659, 668, 698).

The Mule No1 and No2 Grades (423, 426, 430, 434) will qualify for a **25p/kg** premium.

Please note: These premiums will be added to the 2018 graded advance payment.



### APPROVED METHOD OF FLEECE PRESENTATION

After shearing, throw out the fleece onto a clean surface, flesh side down. Fleeces from the Blackface, Herdwick and Rough Fell breeds should be laid flesh side up.

Pick off any extraneous matter and remove any daggings which may have been missed pre-shearing.

Include only clean, dry belly wool with the fleece before folding the flanks toward the centre.

Turn in the britch end

and roll the fleece firmly and neatly towards the neck.

After rolling, part

the fleece.

Without twisting tuck the neck wool firmly into the body of the fleece.



The resulting well presented fleece is firm and secure. Place the tucked fleece firmly into the wool sheet



- **Do** remove all claggs and daggings. There is a price penalty for claggy and undocked fleeces.
- **Do** roll fleeces properly. Please make the effort. Only those fleeces which are rolled can be graded and paid for at fleece wool prices. Wool sent in not rolled can be valued only as "broken" wool, for which the price is much lower.
- **Do** pack different breeds and types of wool into separately-labelled containers.
- **Do** pack oddments separately.
- **Do not** mix hill wool with lowland wool. Kemp from hill wools can cause cross fibre contamination and spoil lowland fleeces.
- **Do not** mix coloured wool with white wool can result in cross fibre contamination.
- **Do not** mix hog wool with wool from ewes and wethers.
- **Do not** mix oddments together with fleece wool.

Should your depot's grader recognise your clip as being excellently presented from farm to depot then you could be awarded one of these certificates.



### **PACKING AND PRESENTATION**



#### UNDER PACKED Sheets cause problems too









We need evenly and well packed sheets. Please remember to store in a clean dry place ideally on a pallet and not in direct contact with a concrete floor

### MAXIMISE YOUR CLIP VALUE

The global wool market is extremely competitive where buyers of wool seek out the most cost efficient supply in order to meet their requirements. Whilst the vast majority of British wool is presented in good condition, we see many avoidable faults that can reduce the value by over 80%.

Please take care to ensure that your wool is delivered to us in good condition.

#### AVOID THESE FAULTS EXCESSIVE MARKING - CODE 'H'

If you do need to mark your sheep, please only use an approved product and use it sparingly. British Wool conduct a licensing scheme for marking fluid manufacturers whereby they submit their products for stringent 'scourability' tests. Only use products bearing the logo on page 7. A list of approved marking fluids may also be found under the producer services section of our website: www.britishwool.org.uk

#### DIP COLOURED - CODE 'T'

Avoid buying sheep that have been bloom dipped. This dramatically reduces the value of the fleece.

#### WET - CODE 'Y'

We have seen an increased number of wet clips being received at our depots. This wool has to be sent away for scouring which adds significant extra cost. Please avoid shearing wet sheep, store the wool in a clean, dry place and ensure that all loads are fully sheeted in transit.

#### DAMAGED - CODE 'F'

Fleeces damaged by dampness, ticks, lice or fly-blown and maggoty. Where fleeces have been shorn or stored in damp conditions, the wool once dried, becomes brittle and heavily discoloured.

Remember to store in a clean dry place and not in direct contact with a concrete floor. Wool is naturally hygroscopic and draws in moisture from the floor.

#### EXCESS VEGETABLE MATTER - CODE 'V'

Whilst this fault can occur naturally from areas of grazing – Heather, moss, bracken etc, many of the cases we see are usually avoidable: Hay, seed, straw, chopped silage. These avoidable faults can cause significant problems to the downstream manufacturers and potentially result in large financial claims.

#### DAGGINGS - CODE 'D'

Less 10p per kg – on weight of the fleece before removal of daggings. Please remove these and discard as they have no commercial value.

#### UNROLLED FLEECES - CODE 'U'

Less 10p per kg – significantly impact on handling efficiency in depots.

#### **POLYPROPYLENE/NYLON CONTAMINATION – CODE `B`** Less 30p per kg.

As the images show, the results can be the rejection of a carpet yarn as these contaminants will not dye as part of the wool process.

Remember ..... it takes a sheep 12 months to grow a fleece. Please don't let a few careless moments ruin it.

### **MINIMISE YOUR TRANSPORT COSTS**

#### There is no transport charge for producers delivering into grading or intermediate depots.

British Wool's nationwide network of hauliers collects wool from farm and our network of local collection centres.

Producers using the transport service will be recharged for their transport costs based upon the weight and number of sheets (or bales) used as per the rates below;

**Collection Centres:** A charge of £5.15 per wool sheet will be made for deliveries to haulier depots and authorised collection sites.

**2,000 kg or over:** A charge of £5.40 per sheet will be made for any pick-up by haulier from a farm.

500 to 1,999 kg: A charge of £7.45 per sheet will be made for any pick-up by haulier from a farm.

**Under 500 kg:** A charge of £10.80 per sheet will be made for any pick-up by haulier from farm.

British Wool seeks to minimise the cost of this service to producers and you can help.

- · If producers work with their neighbours to gather a higher weight of wool at a single location they will be recharged at a lower rate. As a guide 2000kg would be 33 sheets at an average weight of 60kg.
- If producers pack more wool into their sheets they will be charged for fewer sheets - 2000kg would be 25 sheets at 80kg.

### WHY DO WE GRADE WOOL?

The United Kingdom is unique in that it has more native breeds of sheep within its shores than any other country in the world. In addition to this there are numerous cross breeds and continental breeds. British Wool grades wool to internationally recognised standards, the purpose of which is to ultimately add value for downstream manufacturers which enables us to achieve a better producer return. Please note stringent quality control procedures are in place throughout the depots to ensure that end users receive the best possible quality British wool.

### **HOW DO WE GRADE WOOL?**

The Wool graders employed throughout our depots are all highly skilled having initially completed a 5 year training programme. Each individual fleece is graded into 'types' rather than specific breeds, to ensure that the global markets are provided with fleeces possessing the unique characteristics required to suit the end users requirements. These include Fibre fineness (micron), colour, length, strength of staple along with the style which leads British wool to fall into 6 main categories. These are as follows:

### **HOW DO WE SELL YOUR WOOL?**

Once graded, packed and weighed each bale is 'cored' whereby a probe draws a random cross section sample of wool from each bale. Once the full sales lot has been cored, the samples are analysed to International Wool Textile Organisation standards at a laboratory in North Wales. This provides key data on processing and performance characteristics ahead of the wool being offered for sale by auction. The auctions are held on a regular basis throughout the year at our Bradford Headquarters.

### **DELIVERY AND PAYMENT INFORMATION**

### THE SCHEDULE OF PRICES IS BROKEN DOWN<br/>AS FOLLOWS:DELIVERY PERIODS - Wool produced between 1 May<br/>2018 and 31 October 2018, if possible, should be delivered

**THE BALANCE PAYMENT** - Made to producers for their 2017 clip based on the final average price achieved at auction for the 2017 season less the Advance Payment already made, after deducting the handling cost for the 2017 clip.

**THE ADVANCE PAYMENT** - To be made to producers on receipt of their 2018 clip. This payment is made prior to the wool being sold. During our busiest periods in order not to delay paying you while your clip is awaiting being graded, we may make a payment which is calculated based on your weight. Once your clip has been graded you will receive written confirmation of your grades and value.

The prices payable by British Wool for wool produced and delivered in the 2018 season are set out on pages 14 - 17. All prices are expressed pence per kilogram (p/kg) net graded weight and apply only to wool produced in the United Kingdom by the registered producer who offers it for sale to British Wool. There are separate arrangements for lamb wools.

**FAULTS AND DEFECTS** - In the open market, wools which are contaminated with man-made or natural faults will achieve a lower price. These prices are given on page 22 - 23. Equivalent reductions from the price, where appropriate, will also apply to lamb wools and oddments.

**SKIN WOOL** - British Wool is prepared to enter into agreement with fellmongers and others for the handling and sale of skin wool. Such arrangements would not be subject to the provisions of part VI of the British Wool Marketing Scheme 1950, and may provide by arrangement for the transport, handling, storage, financing and sale of skin wool.

**DELIVERY PERIODS** - Wool produced between 1 May 2018 and 31 October 2018, if possible, should be delivered no later than 31 January 2019. Wool produced between 1 November 2018 and 26 February 2019 if possible, should be delivered no later than 28 February 2019.

Wool produced between 27 February 2019 and 30 April 2019 may be delivered at any time during that period or after 1 May 2019, but may not be graded until after 1 May 2019 and will be paid for in accordance with the 2019 Wool Price Schedule.

**OTHER WOOL** - British Wool is not obliged to accept any wool which is not tendered by the registered producer who produced it. If British Wool does accept such wool offered in accordance with Prescriptive Resolution No.1 of 26 February 1981, the price will be mutually agreed. The prices set out on pages 14 - 17 do not apply to any wool imported into the United Kingdom, or to any wool previously sold by British Wool or its agents, and no registered producer may send any such wool to British Wool or its agents.

**VALUATION APPEALS** - A registered producer has a statutory right to see their clip graded, or to send a representative, and ask for their wool to be kept separate from other wools for possible inspection later by a valuation appeal tribunal. If a producer wishes to exercise this statutory right, they must give notice to British Wool, before or when the clip is delivered, that they wish to see their wool graded.

Pursuant to Paragraph 72 (5) as amended, notice of appeal against valuation shall be given to British Wool's Wool Sales Manager in writing signed by the registered producer or their agent within ten days after they receive notification of the valuation.

### THE PAYMENT SYSTEM

British Wool is a farmer owned organisation which, after a grading process, sells wool on behalf of its producers in a series of auctions over a 12 month period. British Wool handles your wool and it sells it on your behalf.

The price paid is the average of that attained over all of the sales during the year, less handling costs, resulting in the same grade wool being paid the same price irrespective of where you farm; the size of your clip or when your wool is received.

The average price gained is not known, and cannot be calculated, until the end of the selling season, and payment is made to you on receipt of your following year's clip.

Payment is made up of two parts, one an Advance Payment when the wool is delivered into British Wool, and the second a Balance Payment which is paid when the following year's clip is received.

#### FREQUENTLY ASKED QUESTIONS

**1.** Why does British Wool not pay the full amount straight away?

British Wool simply does not have the funds to do so as the wool is auctioned on behalf of the producers throughout the year. At the end of October each year upwards of 90% of the wool has been received by depots, but only 25% of the clip will have been auctioned.

**2.** Why does British Wool not pay a much higher advance payment?

The wool market is a global market reliant on many factors outside our control. Auction clearances and prices can be volatile, with potential movements of up to 50% during the season. The amount of unsold stock can vary enormously.

British Wool has to have sufficient funds in order for it to have the ability to be proactive when selling in the auctions and make decisions whether to sell or hold stock so the maximum price can be achieved for producers. This is why we can pay you more than our competitors (see page 3). 3. What about new producers?

British Wool is keen to identify and help genuine new producers into our industry and encourage them to market their wool through us, benefitting from our collective selling power and thus achieving the best price for their wool.

Consequently, we have introduced a scheme for new entrants. This scheme will see eligible producers receive 100% of their clip value\* as an upfront payment in their first two years. Producers will then transition onto the standard payment scheme over the next three years by way of adjusted balancing payments so that, over the life of the 5 year scheme, new entrants receive the same cash as they would have done had they been on the standard payment scheme throughout that period. New entrants are paid the same price per kilo as existing members.

#### SUMMARY

The current payment system has been developed to allow British Wool to operate successfully in any market conditions and to use its collective strength in the marketplace in order to ensure you receive the true market value of your wool.

It is important to remember that British Wool does not buy your wool – it sells wool, on your behalf, thus realising its highest potential value.

#### **EXEMPTIONS**

**1.** Pursuant to Paragraph 70 of the Scheme: in the period 1 May 2018 to 30 April 2019, sales of wool from each of the rare breeds listed below shall be exempt from the provisions of Paragraph 71(1) and 71(2) of the Scheme. The breeds to which this exemption apply are: Balwen, Boreray, British grown Merino, Castlemilk Moorit, Galway, Hebridean, Leicester Longwool, Lincoln Longwool, Llanwenog, Manx Loaghtan, Norfolk Horn, North Ronaldsay, Portland and Soay.

**2.** Pursuant to Paragraph 70 of the Scheme: sales of daggings shall be exempted from the provisions of Paragraph 71(1) and 71(2) and 72 of the Scheme. For the purpose of this Resolution 'Daggings' means wool naturally clotted with dung or earth.

**3.** Sales by a producer of greasy wool for direct physical export to a buyer outside the United Kingdom shall be exempt from the provisions of paragraphs 69 to 72 of the Scheme, unless the export is made with the objective or effect of circumventing the provisions of paragraph 71. Any producer making such sales shall furnish British Wool with proof of export by 1st April of each year.

**4.** If a producer/entrepreneur requires wool for artisanal or craft purposes they may apply to British Wool for exemption from paragraphs 69 to 72 of the Scheme, subject to an annual limit of 3,000 kg. British Wool will generally give approval to such applications, subject to being satisfied that artisanal or craft uses are in fact intended, and that the application is made in good faith.

**5.** If a producer/entrepreneur requires wool for non-textile uses (e.g. insulation materials or composting) they may apply to British Wool for exemption from paragraphs 69 to 72 of the Scheme, subject to an annual limit of 15,000 kg. British Wool will generally give approval to such applications, subject to being satisfied that the criteria are met, and that the application is made in good faith.

#### Value Added Tax Act 1994 s.6(10) (b)

HM Revenue & Customs require British Wool to inform all registered wool producers who supply wool that the date on which the wool is deemed to be supplied to British Wool will be the date on which payment is made.

If payment is made in more than one instalment and the later instalments are paid within eighteen months of the wool being taken by British Wool, part of the wool is deemed to be supplied each time a payment is made by British Wool. This means that suppliers of wool will account for VAT output tax in the VAT return which covers the date on which a payment is made and only to the extent of the output tax included in that payment.





### 2018 OUTLOOK

#### LATEST WOOL PRICES

Whilst no one can forecast wool prices, British Wool is actively marketing your product downstream to support prices over the medium to long-term. In the carpet sector we are currently rolling out a new marketing programme aimed at both the retailer and consumer, our branding licensing scheme will be refreshed in June and we are engaged in product development with our manufacturing partners to help drive demand for British wool.

The chart on page 3 illustrates the auction price of British wool relative to that of New Zealand wool over the last three years. We are encouraged that British wool is now selling at a modest premium to New Zealand wool and that the auction price through the 2017 season has been stable.

As shown in the table below, the prices achieved through the last three sales have, in most cases, been slightly better than the average for the year overall.
